It is to inform that, the MNCFC is conducting ground truth verification from the last five years in partnership with the State Agricultural Department under FASAL project with the Smart phone holded by the trained AOs.

Vide reference 1<sup>st</sup> cited, the MNCFC, GOI during 2019-20 has released an amount of Rs.2,16,000/- to the Department on 06.03.2020 towards logistic expenditure and requested the State to submit the Utilization Certificate for the year 2019-20 .

In this regard, it is to inform that, the Department has conducted the Ground truth verification by utilizing an amount of Rs.4,20,000/- during 2019-20( Kharif Rs. 1.95 Lakhs + Rabi Rs. 2.25 Lakhs) .

The consolidated Utilisation Certificate for the year 2019-20 for an amount of **Rs.4.20 lakhs** is prepared and furnished for information.

Further, it is to inform that, the Government of India has to release an amount of 3.28 Lakhs (Rs. 2.04 Lakhs difference between Release and Expenditure during 2019-20 + Rs.1.24 Lakhs pending releases during 2018-19) to the State for settlement of pending claims .

Hence, it is requested to release the pending amount of **Rs.3.28 Lakhs** to the State at an early date for settlement of pending claims.
